Human African trypanosomiasis (HAT) is a parasitic disease transmitted by tsetse flies. Its gambiense form is endemic in sub-Saharan Africa, but detection and treatment have helped reduce its recorded incidence by 95 percent over the last 20 years. FAO supports efforts to eliminate transmission by 2030.

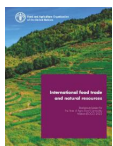

**Estimating the prevalence of nutrient inadequacy from household consumption and expenditure surveys**

Aggregate data on malnutrition is readily available for low- and middle-income countries, but much less is known about precisely what food, and how much of it, the citizens of these countries eat individually. This study posits a new way of inferring such data from household consumption and expenditure surveys.

**Legal report on the ecosystem approach to fisheries in the United Republic of Tanzania - An analysis of the ecosystem approach to fisheries in selected national policy and legal instruments of the United Republic of Tanzania**

These reports assess the extent to which 82 legal requirements, considered the minimum standards in legislating for an ecosystem approach to fisheries, are reflected in the policies and legislation of countries that have such an approach – in this case, the United Republic of Tanzania. The assessment is relevant to fisheries, but also to other related sectors, such as environment, wildlife, ecosystems and maritime affairs.
